No.OE-I.0731180005/2016. 11637 W., Applications are invited from interested retired officers/ (officers retiring as on 31.08.2016) of OSS cadre in the rank of Asst. Section Officer, Section Officer, Desk Officers and Under Secretary only not above the age of 65 years and having good service records and physical fitness for appointment of 4 (four) Nos. of OSD (Officer-on-Special Duty) on contractual basis in Works Department in pursuance of Home Department Resolution No.42595/CC dated 10.10.2011 and comprehensive guidelines enshrined in G.A. Department Resolution No.23750/Gen, dtd. 27.08.2014, Finance Department O.M. No.11497/F., dtd. 07.04.2016 and as approved by Finance Department in their U.O.R. No. 145/WF dt. 14.05.2014.

2. The contractual engagement will be made for a period of one year or as specified (whichever is earlier) which may be extended by further period of one year subject to satisfactory performance and shall not be extended beyond the age of 65 years. The tenure of engagement shall not be more than 4 years including all spells taken together. The competent authority reserves the right to terminate the engagement at any time by giving one month written notice to the appointee. On the contrary, if any re-employed officer desires to resign he shall do so by giving one months written notice to the competent authority.

3. The retired officer against whom a Vigilance Case or Departmental Proceeding or Criminal Prosecution is contemplated or pending or who has been penalised for misconduct during the period up-to five years preceeding to his/ her retirement or is a member of a Political Party will not be considered for re-engagement.

4. The amount of remuneration of the contractual employee shall be determined by the Competent Authority.

5. The period of contractual engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefit.

6. The engaged officer will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining the duty with regard to the truth and correctness of the information furnished by him/ her.

8. As provided in the Resolution No.19637/Gen, dtd. 30.06.1999 of G.A. Department, during the period of contract appointment the appointee may be accommodated in Government Quarters, subject to the availability, provided he pays normal rent as applicable to a Government Servant occupying Government accommodation.

The interested retired officer fulfilling the above criteria may apply with his/ her bio-data, history of service in the Odisha Secretariat with an undertaking that he/ she is not

member of any political party and no Vigilance Case or Departmental Proceeding or Criminal Prosecution is contemplated during the period up to five years preceding his/ her retirement to the undersigned by 04.10.2016.
