(B) Terms & Conditions:

- i. The re-employment will be made for a period of one year or till the vacancy is filled up on regular basis, whichever is earlier.
- ii. In case of receipt of adverse vigilance report, the services will be terminated immediately without any prior notice.
- iii. The re-employed Officer will avail remuneration only in consolidated manner as prescribed in Finance Deptt. Office Memorandum No. Pen-73/18/7022/F, dated: 17.03.2018.
- iv. The re-employment may be terminated at any time by Works Department due to unsatisfactory performance of any of the re-employed officer, by giving one month notice. In case of any misconduct including misappropriation, negligence in duty or causing loss to the Govt., the services will be terminated without any prior notice.

v. Besides the action under condition (iv) above, the re-employed Officer shall be governed by the provisions of Odisha Government Servant's Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions of the Odisha Pension Rules, 1992.

vi. The re-employed Officers are entrusted with the powers and responsibilities as indicated at para 2.2.62, 2.2.64, 2.2.65 and 2.2.66 of OPWD Code Vol-I.

vii. General Instructions of Govt. regarding terms and conditions for re-employment of Officers as issued from time to time will be applicable and binding on the Officers.

viii. In case he desires to resign from the engagement, he may do so by giving one month' in writing to the EIC-cum-Secretary to Govt., Works Department, under intimation to the Controlling Officer. After expiry of the notice period, the Officer may be relieved after handing over the full charges of the records and cash/Bank Accounts to the Relieving Officer as decided by Works Department on the Controlling Officer.

ix. These terms and conditions are subject to Codal Provisions/ Memorandums/ Resolutions issued by Finance Department from time to time.


