This enhanced provision will be applicable only for multi-storeyed E & F type Govt. quarters with facilities for parking in the basement where only one car parking area will be available for each quarter.

In view of the above revision, the earlier provision of Appendix- XXV of OPWD Code Vol.-II stands modified to this effect.
