

1. The appointment is purely on temporary basis and terminable at any time without any prior notice and assigning any reasons thereof.
2. The candidate appointed to the service shall be on probation for a period of 2 (two) years from the date of her joining in the grade/service.
3. The candidate shall be liable to pass the prescribed Departmental and Professional Examination during the period of probation.
4. The inter-se-seniority of the appointee shall be determined in order of merit as assigned to her in OPSC merit list.
5. The appointee should join the office of the Engineer-in-Chief (Civil), Odisha, at Nirman Soudha, Bhubaneswar on any working day falling within a period of 15 days from the date of receipt of this Notification, failing which her appointment shall stand cancelled.






