No. FE-I-PER-0006-2021/ 5236 /W, Pursuant to the recommendation of the OPSC, Cuttack vide letter No. 7187 /PSC, dtd. 31.12.2020 and Department of Water Resources Letter No. 1946 Dtd. 19.01.2021 and in compliance of Order No.1 Dated 24.11.2021 of the Hon'ble High Court of Orissa passed in WP (C) No. 36337/ 2021 filed by Anshuman Palo – vrs – State of Odisha & others and subsequent , SSEPD Department Letter No. 1537 Dated 17.02.2022, Sri Anshuman Palo is provisionally appointed as Assistant Executive Engineer (Civil) under Works Department in Group-A in the Odisha Engineering Service Cadre carrying the scale of pay at pay Level 12 of pay matrix under ORSP Rules-2017, with usual D.A. and other allowances as admissible from time to time with the following terms and conditions.

1. Such appointment is subject to the outcome of the decision of the Hon'ble High Court Orissa in W.P. (C) No.-30386 of 2020, filed by Sri Prafulla Kumar Behera in W.A. No.-733 of 2020 & I.A. No.-1614 of 2020.
2. The appointment is purely on temporary basis and terminable at any time without any prior notice and assigning any reasons thereof.
3. The candidate appointed to the service shall be on probation for a period of 2 (two) years from the date of his joining in the grade/service.
4. The candidate shall be liable to pass the prescribed Departmental and Professional Examination during the period of probation.
5. The Inter-se-seniority of Sri Palo shall be determined in order of merit as assigned to him in OPSC merit list.
6. The appointee should join in the O/o the Engineer-in-Chief (Civil), Odisha, at Nirman Soudha, Bhubaneswar, within seven (07) days from the date of receipt of this Notification, failing which this offer for appointment shall stand cancelled.
7. No T.A/D.A. is allowed to the appointee to join in his place of posting.
8. He should swear an oath of allegiance to the Constitution and give a declaration to the effect that he is not prosecuting studies in any Institution or working in any organisation at the time of joining.
9. He should give a declaration to the effect that he does not have more than one spouse living at the time of joining.

Upon joining, Sri Anshuman Palo is hereby posted as AEE (Civil) in the O/o EIC (Civil), Odisha, Bhubaneswar, against the existing vacancy.
