v.	Chief Engineer concerned to whom the proposal relates	Member Convenor



The Committee shall scrutinize the reasons and justifications (both technical and financial) for Revised Administrative Approval, Deviation, Extension of Time, Closure/Rescission of Contract and any other matter having technical and financial implication as referred to by this Department. The Chief Engineer concerned to whom the proposal relates shall be the convenor of the Committee to fix up the date for the meeting in consultation with the other members.

3. In addition to the scrutiny of the proposal on technical and financial angle, it shall also be the mandate of the Committee to examine serious violation to the codal provisions and flaws in preparation of design and estimate and in accordance of technical sanction. In such cases, the Technical Committee shall recommend Departmental action against the erring officers in a separate report submitted to Works Department in closed cover.


