Applications are being invited from interested retired Group-D employees not above the age of 63 years and having good service records and physical fitness for engagement of 05(Five) Nos. of Group-D employees in Works Department in pursuance of guidelines enshrined in G.A. Department Resolution No.23750/Gen, dtd.27.08.2014, Finance Department O.M. No.7022/F, dtd.17.03.2018 which has been revised vide Finance Department Office Memorandum No.24533/F Dt.29.09.2022 and as approved by Finance Department in their File No.FIN-WF1- MISC-0064-2022.

2. The engagement will be initially made for a period of two years which may be extended by further period of one year subject to satisfactory performance and shall not be extended beyond the age of 65 years. The tenure of engagement shall not be more than 4 years including all spells taken together. The competent authority reserves the right to terminate the engagement at any time by giving one month written notice to the appointee. On the contrary, if any re-employed employee desires to resign he shall do so by giving one month's written notice to the competent authority.

3. The retired employee against whom a Vigilance Case or Departmental Proceeding or Criminal Prosecution is contemplated or pending or who has been penalized for misconduct during the period up-to five years preceding to his / her retirement or is a member of a Political Party will not be considered for re-engagement.

4. The amount of remuneration of the retired employee has been determined by Finance Department vide their O.M. No.7022/F, dtd.17.03.2018 which has been revised in Finance Department Office Memorandum No. 24533 Dt.29.09.2022.

5. The period of engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefit.


6. The engaged employees will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining the duty with regard to the truth and correctness of the information furnished by him/ her.

The interested retired Group-D employee fulfilling the above criteria may apply with his/ her bio-data, with an undertaking that he/ she is not a member of any political party and no Vigilance Case or Departmental Proceeding, Criminal Prosecution is contemplated during the period up to five years preceding the retirement to the undersigned by 01.11.2022.

The Competent Authority reserves the right to reject any or all applications without any reasons thereof.




